 - a) A clear transcript of the applicant's collegiate academic record, including grades received at the end of the first semester of the 2021-2022 academic year. Transcripts do not need to be official and may be emailed or mailed to the Trust. If such a transcript is not available, the applicant must send a personal letter with the application stating why the transcript is not available and the date on which it will be sent to J.B.L.  - b) An *updated* essay describing the applicant's academic and personal goals, summer or other employment experience, and/or areas of growth and learning over the year. *We strongly encourage applicants to submit a refreshed essay* with each renewal application. Essays may be sent as a separate file or typed at the end of the application. Please indicate on the application whether or not permission is granted to publish your submitted essay on the J.B.L.
